**PRIVACY POLICY**

✓ **Strictly necessary cookies.** These cookies are essential to navigate around a website and use its features. **7 - Categories of recipients to whom your Personal Data may be disclosed**

Your Personal Data is kept confidential and will never be disclosed to any other organization except as expressly stated in this Privacy Policy and between our Affiliates. We may disclose your Personal Data to third parties as part of the processing of your specific requests and their satisfaction. For example, if you buy products online using a payment card, we will contact the issuing agency of that credit card or its third-party service provider to process the order, and we will use a business third-party shipping to ship your order or other requested items, such as our catalog or printed materials. **1 - Controller and representative of the EU**

- 1. Based on the need to execute a contract or to conclude one with you: we must process your Personal Data in order to enter into an agreement with you or a legal entity that you represent, to perform contractual obligations, to answer your questions and related requests, to carry out sales transactions or to provide assistance to our customers.
- 2. Based on legitimate interests: we process your Personal Data to:
  - ensure the safety and security of the website, our IT services connected to the website and other users of the website;
  - detect and prevent fraud;
  - protect and defend rights and property of third-parties, or our rights and interests.
- 3. Based on compliance with legal obligations: We may process your Personal Data to comply with applicable laws and regulatory requirements, as well as to respond to legitimate inquiries, court orders and court proceedings.
- 4. Based on your prior consent: to set cookies on your device (subject to certain exceptions) or send you marketing communications.

### 3- Retention period of your Personal Data

- to request the correction or addition of Personal Data about you that is inaccurate, incomplete or out of date with regard to the purposes underlying the processing;
- to obtain erasure of your Personal Data which are no longer necessary for the purposes underlying the processing, which are processed on the basis of a withdrawal of consent or for legitimate interests which, in the case of your objection, are not compelling, or data that is processed are not compliant with the applicable legal obligations. In addition, you have, subject to the conditions set forth in applicable law and without limitation, the right;
- to ask us to limit the processing of your Personal Data in certain situations where you consider that this processing is not appropriate;
- to revoke, in certain circumstances, the processing of Personal Data for legitimate interests;
- to request the portability of Personal Data that you have actively or passively provided (which does not include data derived or deduced from the data collected), when the processing of such Personal Data is based on the consent or on a contract concluded with you and performed by automated means. ## 5 - Automated Profiling and Decision Making


Your Personal Data is not used for profiling purposes or automated decision making by the use of algorithms applied to this data.
